

Assembly And Installation

 Install cage nuts (AA or BA) to appropriate holes on mounting plate (C) depending on what mount will be installed. (See Figure 1)






 Install mounting plate (C) onto column or pipe referring to installation instructions for (FCAVCSU80 or FCAVCSU20) mounting accessory.

Thinstall Mounts (TS118/218/318) and FMSWM

NOTE: If installing to MTMS1U or MTMP1U, proceed to MTMS1U/MTMP1U section.


- Loosely install appropriate hardware (AA and AB) or (BA and BB) to upper cage nut installed in Step 1. (See Figure 2) or (See Figure 3) or (See Figure 4) or (See Figure 5)
- 4. Hang mount onto loosely installed screw and tighten screw. (See Figure 2) or (See Figure 3) or (See Figure 4) or (See Figure 5)
- Use appropriate hardware (AA and AB) or (BA and BB) to secure mount to lower cage nut installed in Step 1. (See Figure 2) or (See Figure 3) or (See Figure 4) or (See Figure 5)



MTMS1U/MTMP1U

Use two or four $5/16-18 \times 7/8$ " button head cap screws (AA) and two or four .750x.350x.060 spacers (AB) to secure mount to top cage nuts installed in Step 1. (See Figure 6) or (See Figure 7)


